- All applications must include the Lombardy Karting Association Agreement of Release waiver attached
- A parent of any minor under the age of 18 must sign and attach the Annual Parental Responsibility waiver.
- A parent of any minor under the age of 18 must provide proof of age if not on file with Lombardy Karting Association.
- Any driver shall submit a completed and signed Medical Self Declaration form. If the applicant is under the age of 19, the Medical Self Declaration must also be signed by a Parent/Guardian.

LOMBARDY KARTING ASSOCIATION CODE OF CONDUCT

Lombardy Raceway Park personnel overseeing testing sessions have the final word regarding all on-track activities. Drivers, crews and spectators are to follow their instructions. Anyone failing to do so will be asked to leave the property immediately.

Practice and testing is intended for drivers to test their skills against the track. Driving wheel to wheel, racing other drivers, aggressive passing and drivers competing with other drivers during practice or testing sessions is not allowed. Such driving is too dangerous for open practice and testing sessions.

No karts will be driven in the paddock area. All karts must be pushed back and forth through the tech garage to pit lane. This is an important safety requirement with cars and trucks entering and exiting the pit area.

All pits must have a fire extinguisher, with current inspection tag. The extinguisher must be in sight and easily accessible.

No one under 18 is permitted to operate a scooter, moped, motorbike, quad, golf kart, etc. at Lombardy Raceway Park.

The only karts permitted to operate at Lombardy Raceway Park are defined as either sprint or shifter-class karts. Fun karts, mini karts, lay down road race karts, cage karts, are not allowed to run at Lombardy Raceway Park.

*All drivers must wear proper driving gear. Safety items include a scuff resistant suit that is designed for karting, gloves, and full face helmet that has a Snell M2005 or later sticker.

All karts and safety equipment must be inspected and pre-approved by the technical director or an authorized track personnel before they are allowed on the track.

All karts must display seasonal inspection tag at all times. Karts will not be allowed on the track if the tag is not visible.

No one other than the driver and Lombardy Raceway Park authorized staff are permitted beyond pit lane when a session is under green or yellow flag conditions.

Drivers under the age of 18 must have a parent or guardian present at all times.

All drivers under the age of 18 must have an annual minor waiver on file with Lombardy Karting Association signed by a parent or legal guardian.

Spectators, crew and/or drivers are not allowed on the track without signing the waiver and obtaining a wristband. Track personnel will be verifying that anyone on the track is wearing a bracelet.

All drivers and crews are expected to leave their pit area clean of trash including zip ties, cigarette butts, bottles, cans, etc.

ALL used tires must be taken home, under no circumstances may tires be disposed of at the track.

Alcohol cannot be consumed by anyone at the track at any time.

All pets must be on a leash and stay within your pit area. **NO** pets are allowed on pit lane, scale or grid area.

Lombardy Karting Inc. reserves the right to revoke a person(s) membership and any or all privileges associated with being a member at anytime as a result of any disciplinary actions. At the time of membership and privileges being revoked, there will not be any reimbursement of monies.

No unauthorized solicitation of products and/or services will be allowed without prior authorization of a Lombardy Karting Inc.

IN CONSIDERATION of being granted the benefits of MEMBERSHIP in the LOMBARDY KARTING ASSOCIATION:

1. **THE UNDERSIGNED**, for myself, my personal representatives, heirs, next of kin, successors and assigns, **DO**:

2. **HEREBY AGREE TO ASSUME ALL RESPONSIBILITY AND LIABILITY FOR ALL ACTS OR ACTIVITIES** of myself, my drivers, assistants and crew for any and all damage or injury that may be caused by any or all of us or by our kart, motor, properties or possessions in anyway growing out of or resulting from the operation of my equipment and/or as a result of participating in any LOMBARDY KARTING ASSOCIATION activities, including practice days, key pass use and or racing events held at Lombardy Raceway Park.

3. **HEREBY AGREE** to be bound by all of the rules of Lombardy Karting Association and agree that decisions of its officials and/or interpretations of its rules will be governed exclusively by the administrative review and appeal procedure set forth in such rules.

4. **HEREBY RELEASE, WAIVE, DISCHARGE AND COVENANT NOT TO SUE THE Lombardy Karting Association** as an association, including all its corporate, elected and appointed officials, all members of committees, referees and inspectors, volunteers, its individual members, its agencies of government which control essential land sites, financiers and firms which render essential service gratis, including all officers, agents and employees of the foregoing and additional volunteer workers assisting in sanctioned **LKA** events, all hereinafter referred to as ***RELEASEES*** from or for any and all liability to me, my personal representatives, heirs, next of kin, successors and assigns, for all loss or damage for bodily injury, death or damage to property of the undersigned which in any way grows out of or results from **LKA** activity or part thereof, during the actual sanction period and whether any such claim may be based upon alleged active or passive negligence whether caused by the release or otherwise, or participation in the wrong, or upon any alleged breach of any statutory duty or obligation, and

5. **HEREBY AGREE TO INDEMNIFY AND SAVE AND HOLD HARMLESS** the releases and each of them from any loss, liability, damage or cost they may incur due to the presence of the undersigned in or upon the restricted area or in any way competing, officiating, observing, or working for, or for any purpose participating in the event and whether caused by the negligence of the releases or otherwise.

6. **HEREBY ASSUME FULL RESPONSIBILITY FOR AND RISK OF BODILY INJURY, DEATH OR PROPERTY DAMAGE** due To the negligence of releases or otherwise while in or upon the restricted area and / or while competing, officiating, observing, or working for or for any purpose participating in the event.

7. **THE UNDERSIGNED EXPRESSLY ACKNOWLEDGES AND AGREES THAT THE ACTIVITIES OF THE EVENT ARE VERY DANGEROUS AND INVOLVE THE RISK OF SERIOUS INJURY AND/OR DEATH AND/OR PROPERTY DAMAGE:** **THE UNDERSIGNED** further expressly agrees the foregoing release, waiver and indemnity agreement is intended to be as broad and inclusive as is permitted by the Law of the Province or State in which the event is conducted and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.

8. **HEREBY ACKNOWLEDGE AND AGREE** that I have no right, property or interest in any radio or television broadcast, motion pictures, still photographs, tape or sound reproduction taken, made, transmitted, reproduced, or used for any purpose of any Lombardy Karting Association sanctioned events, including practice, qualification, the race, awards ceremonies or other events associated with the racing event, also including, but not limited to pictures and sound of me alone or with other persons, with or without racing equipment, as well as any and all receipts there from, and any transcription thereof.

9. **IN CONSIDERATION OF THEIR PROMOTIONAL EFFORTS ON BEHALF OF THE SPORT**, I hereby assign all commercial Communications and broadcast rights to the Lombardy Karting Association, and do declare it as my lawful agent and representative regarding such rights. **I AGREE** the **LKA** or its assigns, on a non-exclusive basis, may use my name and pictures, including pictures of my racing equipment, and pictures taken at any event for publicity purposes.
